



Abstract Submission Authors' Statement and Publication Agreement

Abstracts accepted for presentation will be published in a supplement to *Current Developments in Nutrition (CDN)*. As such, presenting abstract authors must complete the following publication agreement: The undersigned hereby affirm:

- a. The presenting author, acting on behalf of all author(s) and/or authorized representatives hereby provides permission for the publication of the submitted abstract to the ASN effective upon acceptance of abstract for presentation/publication. This permission does not extend to the full length article, if any, on which the Abstract or Work is based. Author(s) retain the right to subsequently include the Work in articles, books, or derivative works that he/she authors or edits, provided that such use does not imply the endorsement of the ASN. Abstracts will be published verbatim using the text and information provided during abstract submission.
- b. The abstract submission identifies all co-authors who have substantially contributed to the concept, data collection and analysis, or preparation of the abstract and therefore may have intellectual property claims to the content.
- c. Each author(s) hereby represents and warrants that he/she/they is/are sole author(s) of the Work, or their portion thereof, that all authors have participated in and agree with the content and conclusions of the Work, and that the Work is original and does not infringe upon any copyright, proprietary, or personal right of any third party.
- d. The publication of this abstract does not require the permission of any other person or organization. All co-authors of this abstract agree to publication.
- e. The facts, conclusions, and opinions stated in the article abstract represent the author's research, conclusions, and opinions and are believed to be substantiated, accurate, valid, and reliable.
- f. Authors must disclose the use of generative AI and AI-assisted technologies in the writing process by adding a statement at the end of their abstract which will appear in an AI Disclosures section. This declaration does not apply to the use of basic tools for checking grammar, spelling, references, etc. If there is nothing to disclose, there is no need to add a statement.
- g. To facilitate publication of meeting abstracts in *CDN* in time for NUTRITION 2024, only essential changes can be made after abstract submission. Essential changes received by March 25, 2024 may be incorporated into the meeting app and *CDN* supplement. Essential changes that cannot be

accommodated before NUTRITION 2024 will be published as an erratum or a corrigendum to the *CDN* supplement.

h. Any addition, deletion or rearrangement of author names in the authorship list will be made only if approved by the editor. To request such a change, the Editor must receive the following from the submitting author: (a) the reason for the change in author list and (b) written confirmation (e-mail, letter) from all authors that they agree with the addition, removal or rearrangement. In the case of addition or removal of authors, this includes confirmation from the author being added or removed.

i. This agreement contains the entire understanding of the parties with respect to the stated subject matter and can be modified only by a signed, written agreement. This agreement shall be construed in accordance with the laws of the State of Maryland.

By checking this, I confirm that (1) I am authorized to submit this abstract as or on behalf of the presenting author and co-authors, (2) the presenting author and co-authors have read and agree to the above terms and conditions, and (3) the presenting author has received permission from their collaborators to present this abstract.
