Note: During the registration process for NUTRITION 2024, you will be asked to agree to the American Society for Nutrition's Registration Policies and Terms & Conditions.

REGISTRATION POLICY

MEMBERSHIP

- To qualify for discounted member registration fees, NUTRITION 2024 registrants must be active members of ASN at the time of registration, OR they must purchase the *Join Now* option.
- ASN will not reimburse the difference between the member and non-member registration fees to any attendee who registers prior to becoming a member.

MISCELLANEOUS

- **Americans with Disabilities Act:** If you require an accommodation to participate fully while attending NUTRITION 2024, please email meetings@nutrition.org.
- For security reasons, all participants in Nutrition 2024 must be officially registered.
- All badge printing is done onsite in Chicago, IL. Badges are required and must be worn and visible at all times. If you misplace your badge onsite, a new badge must be purchased at the replacement cost \$50.00. If your name badge is damaged on site, please bring the damaged badge to on-site registration for a replacement at no charge. A photo ID will be required at the time of replacement.
- Photo identification is required when picking up registration materials on site. Registrants may only pick up their own credentials.

- NUTRITION 2024 educational programming is available on a first-come, first-served basis, including paid conference sessions. ASN recommends arriving early to all scheduled conference activities to guarantee entrance into the room(s).

I hereby knowingly waive and release ASN, its employees, directors, officers, volunteers, agents, successors, licensees, assigns, vendors and sponsors from any and all claims, liabilities, or causes of action, including without limitation, death, bodily injury, property damage, or any other loss, damage, or any inconvenience whatsoever, arising from participation of this meeting and any associated events/activities whether or not such damage, injury, or loss may occur on the premises of the meeting, at off-site venues, in participating hotels or on event ground transportation. I also hereby knowingly waive and release ASN, its employees, directors, officers, volunteers, agents, successors, licensees, assigns, vendors, and sponsors from any and all claims that I may have or may arise regarding the use of my name and image, including any and all claims of defamation, invasion of privacy, or infringements of moral rights, rights of publicity or copyright.

***Be Well release:**

I acknowledge that participation in ASN events and activities brings some risk and I do hereby assume responsibility for my own well-being. ***Security and Registration Credentials:**

REGISTRATION CANCELLATION/REFUND POLICY

Partial Refunds:

- Cancellation requests received by **11:59 PM CT on April 5, 2024**, will receive a 75% refund.
- Cancellation requests received between **April 6 and 11:59 PM CT on May 17, 2024**, will receive a 50% refund.
- No refunds will be given for no-shows.

How to Request a Partial Refund:

- Refund requests must be received in writing by **11:59 PM CT on May 17, 2024**.
- All cancellation and refund requests must be submitted in writing via email to asnnutrition@mcievents.com.
- All attempts will be made to process refunds within 30 days of cancellation. All refunds will be issued back to the original payment type. Cash and money order payments will be refunded by check.

Non-Refundable:

- After **11:59 PM CT on May 17, 2024**, registration fees are non-refundable.
- No-shows (registrants who do not attend) will not receive refunds.
- Donations to ASN are non-refundable.
- ASN One-year Join Now Membership fees are non-refundable.

CODE OF CONDUCT

The American Society for Nutrition (ASN) is committed to ensuring a fair and respectful environment that fosters diversity, equity, and inclusion, and ensures freedom from harassment and abuse. ASN will not tolerate misconduct and violations of ethical behavior or fair treatment of others by fellow participants. We expect all attendees, media, speakers, volunteers, organizers, venue staff, guests, and exhibitors to help us ensure a safe and positive conference experience for everyone by abiding by this Code of Conduct virtually and/or in-person in all venues, including ancillary events and all social gatherings.

- Exercise consideration and respect people and perspectives different from one's own in your speech and actions.
- Refrain from demeaning, discriminatory, or harassing behavior and speech.
- Be mindful of your surroundings and of your fellow participants. Alert ASN staff if you notice a dangerous situation, someone in distress, or violations of this Code of Conduct.

Unacceptable Behaviors Include:

- Intimidating, harassing, abusive, discriminatory, derogatory, or demeaning speech or actions by any participant and at all related events
- Harmful or prejudicial verbal or written comments or visual images related to gender, sexual orientation, race, religion, disability, or other personal characteristics
- Inappropriate use of nudity and/or sexual images in public spaces (including presentation slides)
- Deliberate intimidation, stalking, or following
- Harassing photography
- Photographing slides of oral presentations and posters without the express permission of the presenter/author
- Recording of scientific and other sessions without the express permission of the participants
- Sustained disruption of scientific sessions or other events
- Unwelcome and uninvited attention or contact
- Physical assault (including unwelcome touch or groping)
- Real or implied threat of physical harm

What To Do If You Witness or Experience Conduct That Violates the Code:

ASN staff will assist participants in contacting convention center/hotel/venue security or local law enforcement, and otherwise assist those experiencing harassment, to enable them to feel safe for the duration of the conference. We value your attendance and want to make your experience as productive and professionally stimulating as possible.

Consequences of Unacceptable Behavior

Unacceptable behavior from any participant, including attendees, sponsors, exhibitors, contractors, volunteer leaders, vendors, venue staff, and anyone with decision-making authority, will not be tolerated. Anyone asked to stop unacceptable behavior is expected to comply immediately.

If a participant engages in unacceptable behavior, ASN staff may take any action they deem appropriate, including removal from the meeting, without refund, and/or future ASN meetings. Egregious violations will result in more severe sanctions, including the possibility of reporting to local law enforcement.

MEETINGS & EVENT POLICY

All events, meetings or functions planned in conjunction with ASN in-person and virtual events, outside of official programming, are subject to ASN approval. These events must be coordinated through and comply with ASN's Meeting & Event Space Guidelines and the [ASN Guiding Principles for Relationships with Entities at Interest](#).

CHILD POLICY

- NUTRITION is family friendly! Everyone who attends NUTRITION must be registered and have a badge. Badges for children are free and available in advance or onsite at the registration desk.
- Child guests may be registered online within the attendee registration process.
- Children under 14 years of age must be accompanied by an adult at all times. Guardians are asked to help maintain a professional, disturbance-free exhibition environment.
- Children under 18 are not allowed in the exhibition area during exhibition move-in and move-out for their own safety.
